### Background

The European Union Chamber of Commerce in China (European Chamber) was founded by 51 member companies on 19<sup>th</sup> October 2000. The rationale for establishing the European Chamber was based on the need of the European Union (EU) and European businesses to find a common voice across the various business sectors throughout China.

The European Chamber has grown to more than 1,700 member companies and operates from seven chapters across nine cities: Beijing, Nanjing, South China (Guangzhou and Shenzhen), Shanghai, Shenyang, Southwest China (Chengdu and Chongqing) and Tianjin.

The European Chamber is recognised by the European Commission and the Chinese authorities as the official voice of European businesses in China.

## ADVOCACY

#### **Working Group Meetings**

#### **Business Confidence Survey**

The purpose of the European Business in China Business Confidence Survey is to provide an annual snapshot of European companies' successes and challenges in China. Published since 2004, it serves as a broad indicator as to how European companies judge China's current and future business environment, and allows the European Chamber to analyse the underlying causes of their problems.



#### **EURObiz**








## Flash Survey on the Impact of China's Data Regulations


Launched in November 2023, the report provides an overview of the impact of data regulations and the areas where further steps are needed to optimise the country's regulatory framework for cross-border data transfers.






China's Innovation Ecosystem: the localisation dilemma

#### Seminars


