CICE: CHINA INTERNATIONAL COPYRIGHT EXPO

The State General Administration of Press, Publication, Radio, Film and Television & National Copyright Administration of the People's Republic of China as the organizers, successfully held "China International Copyright Expo" for 4 years in a row, which were positively commented by officials, experts and insiders of the cultural creative industry, including WIPO and NCA. The Expo is the only country-level copyright expo in China to be jointly hosted by the National Copyright Administration of China and the State General Administration of Press, Publication, Radio, Film and Television of the People's Republic of China. The Expo has already become a major research project included under WIPO's Asia Pacific scope. During the Diplomatic Conference of WIPO Protection of Phonographic Performances, "Beijing Treaty on Audiovisual Performances" (abbreviated as "Beijing Treaty") was signed during the period of June 22-24, 2012: more than 700 representatives from 157 countries and 204 organizations from 21 cities and 12 countries attended the Expo. It realized a trading volume of more than RMB 2 billion.



1st CICE

As the first national-level copyright event, the 1st "China International Copyright Expo" was held from 27 to 29, October, 2008 with the opening ceremony held in Beijing Huamao Hotel (JW Marriot Beijing and Ritz-Carlton Beijing). The 1st CICE included key elements integral to the cultural and creative industry, established an international copyright trade platform, laid the foundation for the further development of the industrialization of China's copyright sector. Furthermore, expo stimulated the exchange of information and business resources in the international copyright market –establishing key markets for copyright assets and setting the foundation for broadening copyright market's channels. The three-day 2008 CICE witnessed the signing of nearly 30 projects, covering a broad field of the copyright industry including literary works, film transcripts, and copyright exchange/partnerships.

The 1st CICE was a great success and was highly praised by China National Copyright Administration and World Intellectual Property Organization (WIPO). Francis Gurry, the General Director of WIPO, granted this CICE as the "Olympic Game in the Copyright Industry". This CICE also received widespread praise from professions in the copyright industry over the world, well-known copyright and service corporations, embassies in Beijing. Over 80 press, including CCTV, BTV, Phoenix Television, and a great deal of network media, newspapers, and magazines reported the 1st China International Copyright Trade Expo.

2nd CICE

The 2nd China International Copyright Expo was held on 24, October, 2009, in Beijing International Convention Center. This CICE consists of four sections: International Copyright Forum, Industrial Exhibition, Theme Activities and Cultural Performances. The major content of this CICE includes exhibition and display of copyright achievements, communication and discussion among the industry, promotion of cultural and creative enterprises, individuals and financial institutions and performances such as original Korean Musical and China's Cosplay Competition.

3rd CICE

The "3rd China International Copyright Expo & 2010 International Copyright Forum" was held from 18 to 21, November, 2010 in China National Convention Center. This CICE hosted activities such as "International Copyright Forum", "Global Original Music Concert & WIPO Copyright Awarding Ceremony", "Industrial Exhibition", "Theme Activity" and so on. The major content of this CICE includes top-level copyright seminars, exhibition and display of copyright achievements, communication and discussion among the industry, promotion of cultural and creative corporations, individuals and financial institutions and performances such as original Korean Musical and China's Cosplay Competition. The integration of all the contents showed the industrialization, professionalization, market-orientation and internationalization of this CICE. The core of "Copyright Industrial Chain" linked all the sections together, from copyright achievement display to copyright project promotion, trade, research/discussion, development of the copyright protection technique, which all together deeply impressed the visitors. The 3rd CICE accelerated the development of China's copyright-related industry through active contributions and meaningful explorations in the field.

4th CICE

The 4th China International Copyright Expo was ceremoniously held from 21 to 24, June, 2012 in China International Trade Center Exhibition Hall, and achieved a great success. This CICE, with the principles of "Communication, Cooperation, Innovation, Development", has provided a beneficial environment for promoting the International



Copyright Strategy and China's Copyright Industry's "Going-Out" Strategy. It also established an international and professional trade and communication platform for the achievement of the cultural and creative industry and the copyright industry. Over 700 diplomats and experts in the cultural and copyright industry from 157 countries worldwide came to China, discussed and signed the "Beijing Treaty on Audiovisual Performance", and learned more about the history, development and achievement of China's copyright industry through the 4th CICE. A channel of standardized, professional and international communication on copyright protection and trade was established. The 4th CICE has informed the world of the development of China's copyright industry, internationalized China's copyright corporations, and thus raised the society's consciousness of copyright protection and shared the copyright's intellectual achievement among the world.
